

ELIGIBILITY FOR TUITION REMISSION (EMTD)

Full-time employees, their husbands or wives, and their **dependent** children are eligible for full-tuition remission in program(s) or course(s) of study offered by North Greenville University. Students are required to make timely application for the S.C. Tuition Grant and Pell Grant. Failure to receive a S.C. Tuition Grant or Pell Grant because of late application does not meet the filing requirement. (The Financial Aid Office recommends that all dependents of employees apply for the above grants even if they plan to attend another university. Something may happen to cause a change in plans. A student WILL NOT receive Tuition Remission if the FAFSA is not received by 30 June!)

The tuition grant requirement does not apply to part-time students or those attending Summer session(s). State tuition grants are available to full-time students only.

Tuition Remission is effective only if the employee is employed by the university on registration day of each semester as a full-time (Class I or Class III) employee.

The amount of the EMTD will be determined by the following formula:

Tuition less S.C. Tuition Grant and Pell Grant equals Tuition Remission. Any Private Scholarships may be applied to room and board. The total aid will not exceed the cost of Tuition, Room and Board. Students will be required to pay for books and fees.

Students receiving EMTD are only eligible for other institutional aid that is earned. Earned institutional aid is comprised of aid that the student has to work for; i.e. workstudy, fine arts scholarships, athletic scholarships, and academic scholarships. Students receiving EMTD are therefore not eligible for unearned institutional aid, such as: NGU grant, Endowment, SC Baptist Scholarship, CRV Scholarship, and S.C. Baptist Employee Dependent.

Students receiving EMTD must maintain a minimum GPA of 2.0 and must show satisfactory progress. This scholarship will be awarded for eight semesters of full-time enrollment. Additional semesters must be approved by the Vice President for Admissions and Financial Planning.

The purpose of the EMTD scholarship is to assist students with their university costs. The purpose is not to allow students to “profit” by attending university. Therefore, students with this scholarship shall not receive any refunds above their actual university costs. The Director of Financial Aid shall adjust their financial aid as needed to implement this policy. Students with these scholarships will be expected to purchase their books. For clarification, contact the Director of Financial Aid.

Exceptions to this policy will be made by the Vice President for Admissions and Financial Planning.

Clarifications to the Employee Tuition Discount Policy:

For 2011-12 School Year

- The maximum amount of federal, state, & institutional scholarships & grants for Full- Time Dependent students may not exceed:
\$10,623 per semester for a Resident Student
\$6,698 per semester for a Commuting Student
- Students are responsible for additional charges including fees, premium housing, and books.
- Students may use private scholarships, workstudy, athletic scholarships, and fine arts scholarships (earned) to pay for these additional charges.
